NB: If you do not provide all of this information for each event the athlete cannot be considered for that event. A deposit payment of £250 should be submitted to UKSA at the same time as submitting performances and training information. Deposits are fully refundable if an athlete is not selected for the Championships. Further payments will be required by 10 January 2012.
